




Specific objectives:

- 1) Innovative training of researchers
- 2) Transnational and intersectoral mobility
- International and intersectoral transfer of knowledge
- 4) Co-funding mechanisms



General Information I:

- "bottom-up approach" (No pre-defined research topics)
- Types of Actions
 - Host-driven actions (ITN proposal by a consortia of institutions)
 - 2) Individual actions (IF proposal by an individual researcher together with a host institution)



General Information II:

- Applicants/Participants
 - Early-stage Researchers :
 No doctoral degree or < 4 years' research experience
 - Experienced Researchers :Doctoral degree or ≥ 4 years' research experience
 - 3) Technical and research management staff
 - 4) Academic and non-academic institutions



General Information III:

Mobility rule

Researchers shall not have resided or carried out their main activity in the country of their host organisation for more than 12 months in the 3 years immediately prior to the reference date!

European Researchers´ Night



Innovative Training Network (ITN)

- 1) European Training Networks (ETN)
- 2) European Industrial Doctorates (EID)
- 3) European Joint Doctorates (EJD)

Objectives:

- Training of creative and innovative researchers, which are able to face current and future challenges and to convert knowledge and ideas into products and services for economic and social benefit
- Raise excellence
- Structure the initial and doctoral training of early-stage researchers

Eligibility criteria for ETN and EJD:

- At least three partners located in different MS/AC
- EJD: three partners must be entitled to award doctoral degrees
- Above this minimum institutions from any other country could participate



Innovative Training Network (ITN)

- 1) European Training Networks (ETN)
- 2) European Industrial Doctorates (EID)
- 3) European Joint Doctorates (EJD)

Eligibility criteria for EID:

- At least two partners located in different MS/AC
- At least one partner must be non-academic and one partner must be entitled to award doctoral degrees
- Spend at least 50% of their time in the non-academic sector

Support:

- Early-stage researchers
- Maximum 540 person/month overall, max. 180 for two-partner in EID
- Periods of 3 to 36 months within a 4 year programme
- Mobility rule



Individual Fellowships (IF)

- European Fellowships (EF)
- 2) Global Fellowships (GF)

Objectives:

- Career development (reach a leading independent research position)
- Widening scientific competences and complementary skills
- Enhance the creative and innovative potential

Support:

- Experienced researchers only
- Mobility rule
- Reintegration in Europe after living abroad and a career restart
- Opportunity of an intersectoral secondment of maximum three month (by a total support of 18 month) or maximum six month (by a total support of more than 18 month)



Individual Fellowships (IF)

1) European Fellowships (EF)

Support:

- Researchers of any nationality
- 12 to 24 months research stay in Europe

Career Restart Panel (CRP) and Reintegration Panel (RP)

- CRP: inactive in research for at least 12 month
- RP: mobility into Europe; open to nationals or long-term residents (> 5 years in Europe) of MS/AC
- Modified mobility rule: Researchers shall not have resided or carried out their main activity in the country of their host organisation for more than 3 years in the 5 years immediately prior to the deadline



Individual Fellowships (IF)

2) Global Fellowships (GF)

Support:

- Nationals or long-term residents (> 5 years in Europe) of MS/AC
- 12 to 24 months research stay outside Europe with return phase of
 12 month



Research and Innovation Staff Exchange (RISE)

Objectives:

- International and inter-sector collaboration through research and innovation staff exchanges
- sharing of knowledge and ideas from research to market (vice-versa)
- to develop partnerships in the form of a joint research programme

Eligibility criteria:

- Partners from at least three different countries (at least two must be MS/AC)
- If all are from the same sector, at least one must be from a third country

Support:

- Two-way secondment of researchers and innovation staff + return
- Secondments of 1 to 12 month within a period of 4 years
- Within Europe only inter-sector secondments
- Maximum of 540 person/month



COFUND

Co-funding of regional, national and international programmes (COFUND):

- Aims to stimulating regional, national or international programmes to foster excellence in researchers' training, mobility and career development, spreading the best practices of Marie Skłodowska-Curie actions
- Doctoral programmes: funding of individual research training and career development fellowships for early stage researchers
- Fellowship programmes: funding of individual research training and career development fellowships for experienced researchers
- Target group: single participant from MS/AC that funds or manages doctoral or fellowship programmes for researchers
- Support for at least 3 month



Researchers' Night (NIGHT)

European Researchers' Night

Objectives:

- To bring researchers and science closer to the general public, especially to pupils and students regardless of their prior knowledge or their scientific background
- To raise awareness of the importance of research careers
- Promotion of the gender balance in research and innovation
- To encourage young people to embark on scientific careers


Conditions:

- Typically on the last Friday in September
- Researchers which are founded by Horizon 2020 should be involved
- One call covering 2 years of European Researchers' Night, but a participation over one year is also possible

Application

- Annual calls for proposals (except NIGHT: here one call for two years)
- Information and documents at the EU-Participant Portal
 - Work Programme 2014/2015 → 11 December, 2013
 - Guides for Applicants → ***READ THE GUIDELINES***
 - Submission and Evaluation of Proposals (SEP)
 - Deadline at 17:00 h Brussels time sharp
- Single-stage submission and evaluation procedure
- Research Executive Agency (REA) implements all Marie Skłodowska-Curie Actions on behalf of the European Commission



Application

The proposal is divided into part A and part B:

- A: administrative part
- B: text of the proposal
 - Excellence
 - Impact
 - Implementation
- General conditions:
 - 30 pages + annexes (IF: 10 pages + CV)
 - Page size A4
 - Minimum font size 11 points
 - All margins should be at least 15 mm
 - Font type should be Arial or Times New Roman



Proposal writing tips

- Write in English
- Stick to the guidelines
- Separate sections
- Mark resubmissions as such
 - In the A1 form
 - Optional in Part B (at the beginning): Briefly mention the main weaknesses of the previous version and the improvements made



Evaluation criteria

	Excellence	Impact	Implementation
ITN	50%	30%	20%
IF	50%	30%	20%
RISE	50%	30%	20%
COFUND	50%	30%	20%
Priority	1	2	3

- each criterion will be scored from 0 to 5
- the total score will be subject to a threshold of 70%



Proposal writing tips

- All parts of the proposal are important
- Be as precise and concrete as possible
- Project should be innovative, but realistic
- Mention inter- and multidisciplinary aspects
- Goals and methodology should be clear
- Prepare a clear work plan: work packages, time schedule, milestones, deliveries (Gantt-Chart)
- Be aware of risks and describe alternatives
